# **MEMBERSHIP RECOGNITION – Hall of Fame**

**PURPOSE:** This committee recognizes outstanding Kiwanians for their contributions in work and leadership within the Club and in the community.

**DUTIES:** Each year, sometime in June, July or August, the club president will appoint one person from the membership for a five year term to the Hall of Fame Selection Committee. The Committee will meet and determine who, if any at all, will be viewed as worthy recipients/enshrinees for the "Hall of Fame For Medina Kiwanians".

The number of enshrinees who can be selected for any given year can range from none (0) to three (3). Each candidate must have at least 10 years of Kiwanis membership and must be unanimously approved by the selection committee members. This is the highest honor that any club member can receive from our club. An appropriate HOF Plaque is provided as well as their name engraved on the permanent club plaque.

**GOALS FOR THE YEAR:** Complete the above tasks with timeliness, secrecy and honored dignity. Make sure that all selection committee members are, or have been, appropriately trained and informed as to the selection process and criteria. Age, health and timeliness may be additional considerations when multiple members may appear to be equally qualified for inclusion in the Hall. These generally isolated circumstances are not covered by written by-laws or selection rules but have always been discussed and selectively utilized in the selection process. When a member is to be recognized it shall be in mid-September.

## **MEMBERSHIP RECOGNITION – Legion of Honor**

**PURPOSE:** This committee recognizes member longevity beginning with 25 years of Membership in Kiwanis International.

**DUTIES:** The Legion of Honor status was created by Kiwanis International in 1945 to recognize those members who had exhibited longevity as Kiwanis club members. Therefore, beginning with 25 years of Kiwanis club membership, members are recognized as "Legion of Honor" members. They are provided with a Rhodium pin with the number "25" on it. Then, each five years following (30, 35, 40, etc.) the Legion members are awarded an additional Rhodium Lapel pin with the member's most current number of years' membership displayed. At each of these five year intervals the Legion member is also provided with a certificate from Kiwanis International (purchased by each club secretary) with the member's name, number of years of service and signed by the club president and club secretary.

**GOALS FOR THE YEAR:** Make sure that every deserving and eligible Legion of Honor club member is recognized for their five years with distinction and provided with his/her appropriate pin and certificate. Also, maintain an ongoing list of members who will become eligible for "Legion of Honor" status for each of the next 5 to 10 years. These awards shall be made in mid-January each year.

## **Membership Recognition - Kiwanis International Foundation Awards Committee**

#### Adopted July 2015

**PURPOSE:** The Kiwanis International Foundation (KIF) administers various Fellowships that it awards as a way of recognizing people or clubs who have contributed significantly to Kiwanis' history of generosity. Fellowships are awarded based strictly upon the amount contributed to KIF. It is important to note that KIF bestows many forms of recognition, such as Founders Circle (\$25,000), the Tablet of Honor (\$2.000) Zeller Fellowships (\$1,250) and George F Hixson Fellow (\$1,000) to name just a few. Clubs that contribute funds to KIF may designate the recipient of the fellowship for which the club's contribution qualifies.

**DESCRIPTION:** For years the Kiwanis Club of Medina (KCOM) has been donating to KIF Fund. In recent years the donations to the KIF from our Club were specifically directed towards the 'Iodine Deficiency' fund and most recently towards the 'Eliminate' project. Each donation of \$1,000 qualified our club to receive a Hixson Fellowship medallion which the club in-turn awards to a deserving member.

Any of the KIF forms of recognition shall be handled in the following way. Should the KCOM Board authorize a contribution to KIF that qualifies for a Fellowship award, this committee may select and present the award/s at a regular Club meeting. The decision to acquire any KIF award by the Club must be approved and budgeted for by the KCOM Board of Directors before the KIF Awards Committee may select a candidate(s) for the award.

**SELECTION CRITERIA:** 1) the proposed honoree must be in good standing with the Club during the year he/she receives the award; 2) there is no minimum club membership duration requirement, however, the recipient must be an active participant in the Club's meetings and activities; 3) the committee should give consideration to those members of the Club's Hall of Fame (HOF) who have not otherwise received a KIF award; however, it is not a requirement that HOF members receive a KIF fellowship award before other club members are considered; and 4) a member who has received a Club awarded KIF fellowship is ineligible for any more club bestowed KIF awards.

**COMMITTEE STRUCTURE:** The Kiwanis International Foundation Awards Committee shall be composed of three members: the President Elect, who shall serve as chair and maintain the committee's documentation. There shall be two additional members, each appointed for a two year term on a rotating basis. Each year in <u>June</u> the current president shall appoint one new member for a two year term. The President's appointee shall have received a KCOM bestowed KIF award prior to his or her appointment.

**GOALS FOR THE YEAR:** To select deserving members to receive Kiwanis International Foundation Fellowships as authorized by the Board of Directors.

## **MEMBERSHIP RECOGNITION- Kiwanian of the Year and Nose to the Grindstone**

**PURPOSE:** This is a way to recognize people in the club for their great contributions during the year.

**DESCRIPTION:** These two awards are considered as Presidential discretionary awards. At the close of the Kiwanis year the currently serving President of the club is entitled to designate whomever he/she wishes to receive either to both awards. These awards have no established criteria nor do they require board approval; yet their names suggest some level of accomplishment by the recipient. The Nose to the Grindstone plaque is held by the recipient during the ensuing Kiwanis year and delivered to the succeeding recipient the following year. Any gift/memento given to the Kiwanian of the Year is paid for from club funds budgeted for by the Board. The President is not obligated to bestow either award on any member.
